C.3224 TO CONSIDER THE INCLUSION OF STAKEHOLDER ORGANISATIONS DELIVERING COMMUNITY SERVICES IN THE BUDGET CONSULTATION AND AGREE APPROPRIATE ACTION

Councillor Fox said the proposal was to include Stakeholder and Community Groups in the pre-budget consultation. She had been approached by members of Community Groups who asked if they could be included in the consultation. She thought they would have valuable information to add to the survey. During discussion the following points were raised:

- What community groups, stakeholder organisations could be included
- The original proposal for the survey was for householders in the Camborne Parish to complete the survey
- The possibility that stakeholder responses could be kept separate
- To defer a decision for more information on which groups to include.

The Town Clerk said that due to the timescale, deferment was not an option. In view of the discussions Councillor Fox withdrew her proposition.

Councillor Taylor said the motion was self-explanatory to allow Councillors to have further debate in the light of recommendation 18 of the Root and Branch Review.

C.3227 TO APPROVE RECOMMENDATION 18 OF THE ROOT AND BRANCH ORGANISATIONAL REVIEW OF CAMBORNE TOWN COUNCIL 'THAT THE TOWN COUNCIL SHOULD RESUME FORMAL MEMBERSHIP ON THE BID CAMBORNE BOARD WITH THE TOWN CLERK ATTENDING FUTURE MEETINGS AND ELECTED MEMBERS SHOULD WORK ACTIVELY BOTH FORMALLY AND INFORMALLY WITH BOTH BID AND THE CAMBORNE CHAMBER OF COMMERCE IN PROMOTING THE TOWN'S BUSINESS ECONOMY' AND AGREE ACTION ACCORDINGLY

Members discussed this matter at length. Councillor Mrs Dalley said that at the Vision Day there was a broad agreement that the Council should work with BID Camborne and the Chamber of Commerce for the benefit of the Town. She was, however, concerned that BID Camborne had not adhered to the grant application policy whereby organisations receiving grant funding should acknowledge Camborne Town Council's financial support in promotional material and on their website, if they have one. The Town Council had given a considerable grant to BID Camborne for the Switch-on and there was no mention of the Town Council in BID Camborne's Christmas Lights Switch-on Programme.

Councillors were divided; some thought it important to adopt recommendation 18 while others disagreed. Councillor Webber said that Business Improvement Districts had to be renewed every five years by referendum of Town Businesses. The BID Camborne referendum was in 2017 and he thought the Council could be placed in a difficult position regarding the vote should the Town Clerk be on the BID Board. It was

suggested that the Council explores further ways in which it could work more closely with BID Camborne and invite them to give a presentation to the Council. Following this discussion it was:

C.3227.2 RESOLVED AS A SUBSTANTIVE MOTION:

that Camborne Town Council should work actively with BID Camborne and the Chamber of Commerce in promoting the Town Business Economy and invite BID Camborne to a meeting of the Full Council to give a presentation on how they operate and the work they do

Proposed by Councillor Ms Robinson Seconded by Councillor Chalker

On a vote being taken the matter was approved unanimously

A motion proposed by Councillor Taylor, seconded by Councillor Ms Merrick to approve recommendation 18 of the Root and Branch Review 'that the Town Council should resume formal membership on the BID Camborne board with the Town Clerk attending future meetings and elected members should work actively both formally and informally with both BID and The Camborne Chamber of Commerce in promoting the town's business economy' was defeated by the Substantive Motion.

C.3228 TO APPROVE A MOTION FROM COUNCILLOR A CRICKETT:

'TO FULLY SUPPORT ST MICHAELS HOSPITAL IN HAYLE AND OPPOSE ANY PRIVATISATION OF SERVICES AT ST MICHAELS AND ANY EFFORT TO CLOSE IT. THE COUNCIL ALSO RESOLVES TO WRITE TO NEIGHBOURING TOWN AND PARISH COUNCILS TO SUPPORT THIS. THE COUNCIL ALSO RESOLVES TO WRITE TO AND INVITE GP'S IN THE PARISH TO ATTEND A MEETING WITH A VIEW TO GETTING MORE REFERRALS TO ST MICHAELS'

Councillor Crickett said that, five years ago, petitions were signed and 30,000 people marched to stop the closure of St Michaels Hospital. There seemed to be a policy of non-referrals to St Michaels to make it easier to close if it could be shown to be underused. Members discussed Councillor Crickett's motion at some length. Points raised included the Kernow Clinical Commissioning Group (KCCG) criteria for referring patients to St Michaels; statements from the RCHT, the MP, Mr Boswell, Joy Youart and others that there were no plans to close St Michaels; the excellent care at St Michaels; people not being offered St Michaels for their treatment; legal rules that the Commissioning Group had to abide by and the closure of Poltair Hospital following assurances that Poltair would not close

C.3228.2 RESOLVED:

to fully support St Michaels Hospital in Hayle and oppose any privatisation of services at St Michaels and any effort to close it. The council also resolves to

write to neighbouring town and parish councils to support this. The Council also resolves to write to and invite GP's in the parish to attend a meeting with a view to getting more referrals to St Michaels

Proposed by Councillor A Crickett Seconded by Councillor M Champion

On a vote being taken the matter was approved by a majority vote

An amendment moved by Councillor Odgers, seconded by Councillor Taylor, to fully support St Michaels Hospital in Hayle and oppose any privatisation of services at St Michaels and any effort to close it; to write to the Chief Executive of Kernow Clinical Commissioning Group (KCCG) Ms Joy Youart in support of its criteria for sending patients to St Michaels Hospital; was defeated by the proposition.

A further amendment proposed by Councillor Godolphin, seconded by Councillor White to fully support St Michaels Hospital in Hayle and oppose any privatisation of services at St Michaels and any effort to close it; was defeated by the proposition.

C.3229 TO RECEIVE A LETTER FROM THE CAMBORNE CHAMBER OF COMMERCE, CAMBORNE REGENERATION FORUM AND BID CAMBORNE REGARDING GURNEYS LANE TOILETS AND AGREE ANY ACTION (C.3138.2)

A draft response from Councillor Ms Robinson to the letter received from the above mentioned organisations was circulated at the meeting. It explained the reasons for the Town Council not taking on the toilets in Gurneys Lane and a wish that the Town Council explore community toilets as a way forward. Councillor Merrick asked whether a response should be deferred until after the results of the consultation. Councillor Godolphin commented that other Towns were finding the toilets extremely expensive to maintain. Following further discussion it was:
